The exhibits at the Annual MDAEYC 2010 Fall Conference are intended to support the educational goals of the conference. Acceptance of exhibits is at the discretion of MDAEYC and the Exhibit Coordinator.

No exhibitor shall assign, sublet or share the space reserved without the authorization of the Exhibit Coordinator for the conference.

Formal acceptance of reservation forms by the Exhibit Coordinator, as an agent for the conference, constitutes a contract for the right to use the space provided.

Space will be assigned based on the date the exhibit reservation is received. Other considerations include display design, access and traffic flow along with health and safety rules. Specific requests from exhibitors will be honored when possible. The Exhibit Coordinator will assign exhibit space.

Exhibitors are encouraged to take all precautions for the safety of their materials and/or equipment.

Exhibitors must adhere to any rules and regulations as set by Baker College of Auburn Hills.

Displays must not obscure the view of an adjacent exhibit.

Live music/entertainment, recorded music, videotapes, or other auditory displays must adhere to the 15 minute on and 15 minute off policy.

Exhibitors will hold harmless MDAEYC, the conference committee, conference sponsors, and Baker College of Auburn Hills in the event of any liability, responsibility, loss, damage, cost or expense of any kind arising directly or indirectly from any intentional or negligent act or omission by the exhibitor or any of its agents or employees.
